Sub: Training of All India officers (IAS and Forest service) in preparation of District Irrigation Plans under Pradhan Mantri Krishi Sinchai Yojana (PMKSY).

Dear Sir,

You are aware that in a meeting chaired by the PM on 8/6/15, the following decision was taken:

"IAS and IFS (Forest) service officers of the three junior most batches may be assigned a district each for preparation of the District Irrigation plan. They should spend at least one month in the district, interact with all stakeholders and prepare a document which could be used as the primary source. Likewise State civil and forest officer trainees may also be associated with the above task in consultation with State Governments. All the information so collected should be integrated on a digital platform using the available resources with Department of Science and Technology (DST) and Department of Agriculture & Cooperation (DAC)."

Meanwhile the Cabinet approval for PMKSY was received on 06.07.2015 and DAC has started taking necessary action to expedite the work on the above. In this context, JS Mission for Integrated Development of Horticulture (MIDH) and On Farm Water Management (OFWM) along with JS in Department of Land Resources (DoLR) held a meeting with the heads of all training intuitions of Indian Council of Agricultural Research (ICAR), Ministry of Rural Development and Ministry of Water Resources at National Institute of Rural Development & Panchayati Raj (NIRD&PR) Hyderabad on Monday, the 6th July to prepare a training module, and the basic contours of the DIP.

The following five institutes have been identified to conduct the one week training programme for the states covered in their region as per schedule given below.
