Sir,

I am directed to convey the sanction of the Competent Authority for **Rs. 16,32,85,849/- (Rupees Sixteen crore thirty two lakh eighty five thousand eight hundred forty nine only)** to NABARD against the interest subvention under Micro-Irrigation Fund for quarter ending **March, 2023**. The sanction is against the demand received vide Ref. No. NBSPD/500/MIF Interest Subvention/2022-23 dt. 23.02.2023 of NABARD.

2. The release of funds is subject to the following conditions:
 - i. The accounts of the agency shall be open to internal audit of the Principal Accounts Officer, Department of Agriculture & Farmers' Welfare as well as Statutory Audit by the Comptroller and Auditor General of India at his discretion and he shall have the right to demand the production of books, accounts, connected vouchers and other documents and papers in this regard.
 - ii. As it is a reimbursement fund, hence, the grantee institution is not required to submit Utilization Certificate on PFMS.
 - iii. The payment to NABARD towards Interest Subvention under Micro Irrigation Fund has been waived for notifying the SNA as per new guidelines of M/o Finance for CSS O.M. No. 1(13)/PFMS/FCD/2020 dt. 23.03.2021 approved by Secretary(A&FW) vide Note#153 FTS 83346 dt. 06.06.2022 in concurrence with IFD.
 - iv. The Grants-in-Aid being released by the sanction order is only reimbursement of funds.
