Subject: Sanction of Rs.16,10,41,957/- (Rupees Sixteen crore ten lakh forty one thousand nine hundred fifty seven only) to NABARD against the interest subvention under Micro-Irrigation Fund for quarter ending December 2021-reg.

Sir,

In supersession of earlier sanction of even no. dated 03.12.2021, I am directed to convey the sanction of the Competent Authority of **Rs.16,10,41,957/- (Rupees Sixteen crore ten lakh forty one thousand nine hundred fifty seven only)** to **NABARD** against the interest subvention under Micro-Irrigation Fund for quarter ending December 2021. The sanction is against the demand received vide Ref. No. NB SPD/282/MIF Interest Subvention/2021-22 dt. 24.11.2021 of NABARD.

2. The release of funds is subject to the following conditions:
 - i. The accounts of the agency shall be open to internal Audit of the Principal Accounts Officer, Department of Agriculture & Farmers Welfare as well as Statutory Audit by the Comptroller and Auditor General of India at his discretion and he shall have the right to demand the production of books, accounts, connected vouchers and other documents and papers in this regard.
 - ii. All grantee institutions shall submit Utilization Certificate on PFMS.
 - iii. The payment to NABARD towards Interest Subvention under Micro Irrigation Fund has been waived for notifying the SNA as per new guidelines of M/o Finance for CSS O.M. No. 1(13)/PFMS/FCD/2020 dt. 23.03.2021 approved by Secretary (A&FW) in concurrence with IFD vide. Note#300 FTS 83295 dt. 20.09.2021.
 - iv. The further use of Grants in Aid being released by this sanction order, is to be done through EAT Module of PFMS. The Utilization Certificate not supported by the EAT Module data is likely to be rejected and expenditure is not to be treated as regular. The agency would be forced to refund the amount received as the expenditure not appearing in EAT module data is not to be taken as expenditure incurred in accordance with the terms and conditions of this Sanction Order.
