Subject: Funding pattern of Centrally Sponsored Schemes – Micro Irrigation under PMKSY.

Sir/ Madam,

I am directed to state that the competent authority has revised the funding pattern of various schemes including Centrally Sponsored Scheme on Micro Irrigation under PMKSY for 2015-16. Accordingly, the funding pattern shall now be 60:40 between the Central Govt. share and State Govt. share for all States except North Eastern States and Himalayan States. The funding pattern shall be 90:10 for North Eastern and Himalayan States.

2. The revised sharing pattern between Central Govt. and State Govt. share for financial assistance for Centrally Sponsored Scheme on Micro Irrigation under Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) during 2015-16 will be as under: -
