I am directed to inform that the unspent balance in respect of fund released in the financial year i.e. 2018-19 under Per Drop More Crop (Micro Irrigation & Other Interventions) component of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY-PDMC) stands revalidated for utilization on approved activities of the Scheme during FY 2019-20.

- Revalidation of unspent balance will be adjusted against release of first/second instalment and allocation of current financial year will be reduced to that extent. The Annual Action Plan (AAP) for implementation of PMKSY-PDMC during 2019-20 have to include unfinished/spill over activities as also the committed liabilities of previous financial year.
- Utilization Certificates, Balance Sheet and Audited Statement of Accounts of State 3. Government/implementing agency should clearly reflect unspent balance at the beginning of the financial year, so that this amount is accounted for, in a transparent and unambiguous manner.
- As per Rule 230(8) of GFR 2017, all interests of other earnings against Grants-in-aid or advances (other than reimbursement) released to any Grantee institution should be mandatorily remitted to the Consolidated Fund of India immediately after finalisation of the accounts. Such advances should not be allowed to be adjusted against future releases.
- As regard to unspent balance available from the funds released for implementation of PDMC 5. (Micro Irrigation & Other Interventions) before 2018-19, revalidation will be done only with the concurrence of IFD of this Department for which proposal with full justification is required to be submitted to this Department separately for consideration.
