Sir,

I am directed to convey the sanction of the Competent Authority of Rs. 6,61,07,863.0/- (**Rupees Six crore sixty one lakh seven thousand eight hundred sixty three only**) against the interest subvention under Micro-Irrigation Fund for quarter ending December 2020. The sanction is against the balance funds of the demand received vide Ref. No. NB. FD. HO. B&B BO/ 358/MIF/2020-21 dt. 23.11.2020 of NABARD.

2. The release of funds is subject to the following conditions:

- i. The accounts of the agency shall be open to internal Audit of the Principal Accounts Officer, Department of Agriculture, Cooperation & Farmers Welfare as well as Statutory Audit by the Comptroller and Auditor General of India at his discretion and he shall have the right to demand the production of books, accounts, connected vouchers and other documents and papers in this regard.
- ii. All grantee institutions shall submit Utilization Certificate on PFMS.
- iii. The further use of Grants in Aid being released by this sanction order, is to be done through EAT Module of PFMS. The Utilization Certificate not supported by the EAT Module data is likely to be rejected and expenditure is not to be treated as regular. The agency would be forced to refund the amount received as the expenditure not appearing in EAT module data is not to be taken as expenditure incurred in accordance with the terms and conditions of this Sanction Order.


3. The expenditure of Rs. 6,61,07,863.0/- (**Rupees Six crore sixty one lakh seven thousand eight hundred sixty three only**) to NABARD shall be transferred through RTGS and would be met from the following Head of Account of Pradhan Mantri Krishi Sinchai Yojana (PMKSY)- Per Drop More Crop for the year 2020-21 (BE):
